- Offer support services that ensure good final quality for our and the customer's product.
- Offer knowledge about the environmental consequences of using our products.
- Offer a return scheme for packaging when possible.
- Through searching and communicating up-to-date knowledge and expertise.

- All employees must have the necessary training to ensure that they are aware of and understand the company's policy for climate and environment as well as associated procedures and practices.
- Document our environmental compliance through ISO 14001 certification.
